### **ABSTRACT**

This study entitled: " The Behaviour of the Grade 11 Students of John B. Lacson Foundation Maritime University-Molo towards Learning " aims to describe the behaviour Grade 11 students of John B. Lacson Foundation Maritime University-Molo towards their study. The respondents were 30 chosen Grade 11 Students from the selected Grade 11 sections of John B. Lacson Foundation Maritime University-Molo. Series of questionnaires was provided by the researchers to be answered by the respondents.

Specifically, this study sought to answer the following questions:

1. How do the Grade 11 Students of John B. Lacson Foundation Maritime University-Molo behave during class discussion, do they listen attentively to the teacher?
2. Where does the Grade 11 Students of John B. Lacson Foundation Maritime University-Molo prefer to study: at home or at school?
3. How do their parents discipline their child/children's behavior towards their studies?
4. How do the teachers discipline the Grade 11 Students of John B. Lacson Foundation Maritime University-Molo in their learning at school?

The following are the findings of the study.

1. The Grade 11 students of JBLFMU-Molo tend to behave well inside their classroom during their class discussion where they were just sitting and listen to their teacher while discussing.
2. The Grade 11 students of JBLFMU-Molo prefer to study at home due to the reason that at home no one will interrupt them while studying or doing their homework.
3. The students were disciplined by their parents in the way of motivating them to study hard.
4. The students were being called their attention because of the unfavourable attitude inside their room during their class discussion.

However it was revealed that students only behave and pay attention only on the subject where they prefer to behave and participate. Students prefer to study at home due to the reason that at school the place is not conducive for learning because of the noise and of the unfavourable behaviour of some of their classmates. It was also revealed that some of the teachers of the Grade 11 year level tolerates the unfavourable behaviour of their students, which it affects the whole class during their class discussion.

It was therefore recommended that teachers will make their class a thing that students will come back every day. They should encourage their students to attend their everyday class. School administration shall provide a place in school where students will study, a place where there is silence where students can concentrate while they are studying. Teachers should not tolerate the unfavourable behaviour of their students. They should be more strict in disciplining their student's behaviour inside their class. By this simple steps, it will develop the behaviour of the Grade 11 Students and would increase their academic performance in school.
